INFORMATION ON SHARE BUY-BACK PROGRAMME

Milan, 17 November 2014. We hereby notify that, in the framework of the authorization to buy and disposal of treasury shares under the Company's Shareholders' Meeting resolution adopted on 16th April 2014 and following the launch of a buy-back programme by the Board of Directors on 6th November 2014, Prysmian S.p.A. (the "Company") purchased on the regulated market managed by Borsa Italiana from 10th to 14th November 2014, both included, no. 500,000 shares with an average price of Euro 14.2729 per share, for a total amount of Euro 7,136,440.

On November 14th, 2014, considering also the abovementioned transactions, the Company directly and indirectly owns no.2,152,427 treasury shares, equal to about the 0.99% of the share capital, as currently attested at the Milan Company Register.
