## INFORMATION ON SHARE BUY-BACK PROGRAMME

*Milan, 22 December 2014.* We hereby notify that, in the framework of the authorization to buy and disposal of treasury shares under the Company's Shareholders' Meeting resolution adopted on 16<sup>th</sup> April 2014 and following the launch of a buy-back programme by the Board of Directors on 6<sup>th</sup> November 2014, Prysmian S.p.A. (the "Company") purchased on the regulated market managed by Borsa Italiana from 15<sup>th</sup> to 19<sup>th</sup> December 2014, both included, no. 134,000 shares with an average price of Euro 14.3742 per share, for a total amount of Euro 1,926,147.

Here below the details of the buy-back transactions on daily basis:

Since the beginning of the buy-back programme, the company has purchased no. 1,390,000 ordinary shares for a total amount of Euro 19,954,278.

On December 19<sup>th</sup>, 2014, considering also the abovementioned transactions, the Company directly and indirectly owns no. 2,830,318 treasury shares, equal to about the 1.3% of the share capital, as currently attested at the Milan Company Register.
