INFORMATION ON SHARE BUY-BACK PROGRAMME

Milan, 26 June 2017. Prysmian S.p.A. hereby notify that, in the framework of the current authorization to buy and disposal of treasury shares under the Shareholders' Meeting resolution adopted on 12th April 2017 and of the share buy-back programme launched by the Board of Directors on 12th January 2017, has purchased on the regulated market (MTA) managed by Borsa Italiana from 19th to 23rd June 2017, both included, no. 16,145 shares with an average price of Euro 25.9105 per share, for a total amount of Euro 418,324.62.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back programme, here below the details of the shares purchase transactions, on daily basis, in aggregate form:

Since the beginning of the share buy-back programme, Prysmian S.p.A. has purchased no. 3,977,163 ordinary shares for a total consideration of Euro 98,190,955.51.

As of June 23rd, 2017, considering the abovementioned purchases, Prysmian S.p.A. directly and indirectly owns no. 6,539,881 treasury shares, equal to about the 3.02% of the share capital.
